**Rank 1**—(Goal 1) Promote public health, environmental awareness, and passion for outdoors by connecting population (especially youth) with outdoor recreation.

**Rank 2**—(Goal 9) Improve transportation infrastructure and performance to facilitate recreational access to a wide-variety of recreation opportunities (e.g., parking, mass-transit, ride sharing, etc.).

Rank 3—(Goal 8) Manage growth in demand for recreation by identifying areas where higher levels of recreation use could be acceptable and facilitating increased visitation in these areas (e.g., ski resorts during the summer).

**Rank 4**– (Goal 6) Develop closer interagency coordination to complete recreation projects (e.g., multijurisdictional recreation management strategies and trail networks).

**Rank 5**—(Goal 7) Provide a range of opportunities for high quality recreation experiences supporting a variety of activities.


